

RESOLUTION NO. 2026-003

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE REINSTATEMENT AND FIRST AMENDMENT TO THE AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF COCONUT CREEK FOR FUNDING AND ADMINISTRATION OF FISCAL YEARS 2020-2024 CARES ACT COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG-CV) AND COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG) (CFDA #14.218 / FAIN # B-20-MW-12-0054, B-21-UC-12-0001, B-22-UC-12-0001); PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City is designated as an entitlement community pursuant to 24 C.F.R Part 570.4, with a population in excess of 50,000, entitling the City to receive Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD) and implement its own CDBG programs; and

WHEREAS, on September 27, 2007, the City Commission of the City of Coconut Creek approved a motion to accept the City as an entitlement grantee of federal funds from HUD and the responsibilities associated with that status; and

WHEREAS, HUD encourages the establishment of joint local housing assistance programs, and authorizes local governments to enter into interlocal agreements (ILA) to establish and implement such programs; and

WHEREAS, the City of Coconut Creek and Broward County entered into an Interlocal Agreement on September 12, 2024, for Broward County to administer the City's allocations of CDBG and CDBG-CV Program funding for Fiscal Years 2020-2024; and

WHEREAS, the City of Coconut Creek entered into an agreement on April 13, 2023, with Master Mechanical Services, Inc., authorizing the utilization of CDBG funds for the Recreation Complex HVAC Replacement Project; and

WHEREAS, Broward County requires the City to reinstate the ILA for Fiscal Years 2020-2024 CDBG and CDBG-CV funding and administration to amend the ILA expiration date necessary for the completion of the Recreation Complex HVAC Replacement Project; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the residents of the City of Coconut Creek to enter into the reinstated and amended agreement with Broward County for the administration of the City's Fiscal Years 2020-2024 CDBG-CV and CDBG funding for completion of the Recreation Complex HVAC Replacement Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached Reinstatement and First Amendment to the Agreement between Broward County and the City of Coconut Creek for funding and administration of the City's Fiscal Years 2020-2024 CDBG-CV and CDBG funding for completion of the Recreation Complex HVAC Replacement Project.

Section 3: That the City Manager, or designee, is hereby authorized to execute said agreement between Broward County and the City of Coconut Creek for funding and administration of the City's Fiscal Years 2020-2024 CDBG-CV and CDBG funding for completion of the Recreation Complex HVAC Replacement Project.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
