

## **RESOLUTION NO. 2025-164**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE MAYOR AND THE CITY MANAGER, OR THEIR DESIGNEES, TO EXECUTE THE ATTACHED REVOCABLE LICENSE AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF COCONUT CREEK, AUTHORIZING THE CITY TO INSTALL, OPERATE, AND MAINTAIN SCHOOL ZONE SPEED DETECTION SYSTEMS ON COCONUT CREEK PARKWAY AND WILES ROAD; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek enacted Ordinance No. 2024-028 on July 11, 2024, authorizing the placement and installation of speed detection systems on roadways maintained as school zones in accordance with Section 316.1896, Florida Statutes; and

**WHEREAS**, certain speed detection systems will be located in the right-of-way along on Coconut Creek Parkway and Wiles Road, identified as the Revocable License Area set forth in Exhibit A ("Revocable License Area") of the attached Revocable License Agreement; and

**WHEREAS**, Broward County owns and controls the Revocable License Area and the portions of Coconut Creek Parkway and Wiles Road that appear in Exhibit A, all of which lie within the jurisdictional boundaries of the City; and

**WHEREAS**, the City seeks, and Broward County is amenable to, the City's nonexclusive access and use of the Revocable License Area to install, operate, and maintain a school zone speed detection system ("SD System," as further detailed in Exhibit B of the Revocable License Agreement) in accordance with the terms and conditions of the agreement; and

**WHEREAS**, under this Revocable License Agreement, the City will assume responsibility for the installation, operation, and maintenance of the school zone SD System located in the Revocable License Area; and

**WHEREAS**, this agreement will be in place in perpetuity unless terminated.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE  
CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached Revocable License Agreement between Broward County and the City of Coconut Creek, authorizing the City to install, operate, and maintain school zone SD Systems along Coconut Creek Parkway and Wiles Road.

**Section 3:** That the Mayor and the City Manager, or their designees, are hereby authorized to execute said Revocable License Agreement between Broward County and the City of Coconut Creek authorizing the City to install, operate, and maintain school zone SD System along Coconut Creek Parkway and Wiles Road.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
