RE: Letter of Consistency with FDOT Procedures
Transportation/Mobility/Safety Improvements
Sample Road from Lyons Road to Tradewinds Park
Broward County Mobility Advancement Program (MAP) Project No. COCO-016

Please accept this letter as a notification to the County's MAP Administration that the City of Coconut Creek has expressed a desire to construct transportation, mobility, and safety improvements along Sample Road, in Florida Department of Transportation (FDOT) right-of-way from Lyons Road to the entrance of Tradewinds Park. The Department understands the project was approved as part of the Broward County Surtax / Mobility Advancement Program and we are committed to working with the City and County.

The project improvements include special emphasis crosswalk markings, shared-use paths, and bus infrastructure with minor modifications related to drainage and harmonization. The Department has established resources for guidance related to these improvements, including the Florida Design Manual (FDM); Chapter 222 (222.2.3 Crosswalks), Chapter 224 (General Shared Use Path), Chapter 225 (Public Transit Facilities). In November of 2022, the FDOT (Traffic Operations Office) provided conceptual support for the installation of special emphasis crosswalk markings at the intersection of Sample Road and the Tradewinds Park entrance in response to the City's request.

Conceptually, the project is consistent with the Department's objectives, and we do not have any concerns with the project moving forward into the design phase. The project is a transportation improvement project supporting safety and mobility for all users. The project will be expected to adhere to the Department's permitting requirements, applicable design criteria, and any maintenance agreements determined to be necessary.
