A Public hearing meeting for Luna Christian Academy(LCA) was held at 3720J Coconut Creek Pkwy, 33066 on October 18,2023 from 11:00am-2:00pm. About a week prior to the meeting, a notice was sent to the tenants via email and in person.

During the meeting, a PowerPoint presentation was utilized to familiarize tenants with the services that Luna Christian Academy would be rendering to the community. Participants were excited about the opening of the new school and offered their assistance, if needed. Mr. Ryan Christoff of Back in Action is a Physical Therapist who have been a tenant of the building since 1997 had questions about the age group of the students and when operation is set to begin. I explained that I am awaiting final approval from the City of Coconut Creek before proceeding with the grand opening of LCA. A representative of Abundant Abilities explained to me that the mission of Abundant Abilities is to provide assistance to Autistic students from ages 3 and up through therapy. I found this information beneficial since I anticipate the possibility of having students with Autism at my school. Although the other tenants did not attend the meeting, I had an opportunity to meet with them all during the distribution of the Public hearing notice.

The attitudes of the tenants were pleasant and no one displayed any negative concerns regarding the opening of LCA.

Conclusion: The meeting was concluded at 2:00pm. The meeting provided insight of the goods and services that the tenants in the building provided to the community. I was ecstatic about building a relationship with these tenants as they provided services that would benefit my clients.
