

**RESOLUTION NO. 2025-047**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A CONSULTING SERVICES WORK AUTHORIZATION FOR GENERAL PROFESSIONAL ENGINEERING SERVICES WITH CPH, LLC TO PROVIDE DESIGN, PERMITTING, AND BIDDING SERVICES FOR THE UPGRADE OF A WASTEWATER FORCEMAIN PRIMARILY ALONG NW 39 AVENUE AND NW 74 STREET, NORTH OF HILLSBORO BOULEVARD, IN ACCORDANCE WITH RFQ NO. 03-25-20-02; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek (City) is responsible for maintaining a four (4)-inch wastewater forcemain that runs north of Hillsboro Boulevard along NW 39 Avenue and NW 74 Street for wastewater services; and

**WHEREAS**, as the area develops, the original design capacity of the four (4)-inch wastewater forcemain is approaching its limits for reliable and uninterrupted service; and

**WHEREAS**, to accommodate on-going and future development in the area, it is necessary to upgrade the capacity of the existing wastewater infrastructure; and

**WHEREAS**, pursuant to Resolution No. 2020-196, the City has an agreement with CPH, LLC to perform general professional engineering services; and

**WHEREAS**, CPH, LLC reviewed the City's existing utilities conditions and provided a proposal, attached as Exhibit "A" to the Consulting Services Work Authorization, to provide design, permitting, and bidding services for the upgrade of the existing wastewater forcemain at a cost of \$124,700; and

**WHEREAS**, the City Commission finds and determines it to be in the best interest of the City to approve the Consulting Services Work Authorization with CPH, LLC to provide design, permitting, and bidding services for the upgrade of the existing wastewater forcemain.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached Consulting Services Work Authorization between the City of Coconut Creek and CPH, LLC to provide design, permitting, and bidding services for the upgrade of the existing four (4)-inch wastewater forcemain.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the attached Consulting Services Work Authorization between the City of Coconut Creek and CPH, LLC for the aforementioned services.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
