

**RESOLUTION NO. 2024-102**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND ASTRIATA, LLC, ATTACHED HERETO AND MADE A PART HEREOF AS ATTACHMENT "A," TO PROVIDE CITY WEBSITE DESIGN AND IMPLEMENTATION SERVICES PURSUANT TO IFB NO. 05-29-24-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City's intent of this service contract is to establish an agreement with experienced and qualified firms to provide the City website design and implementation services; and

**WHEREAS**, the current City website is in need of an updated interface, a more functional navigational structure, and a more brand-cohesive look, based on a web responsive design, which meets ADA compliance standards; and

**WHEREAS**, on April 28, 2024, the City issued four-hundred-seventy-nine (479) electronic invitations through the eBid System and received two (2) responsive submittal(s); and

**WHEREAS**, the Procurement Division reviewed the bid responses for compliance; and

**WHEREAS**, based upon the schedule of bid prices outlined in Exhibit "A" of the agreement, as well as the information in their bid and the results of the background and reference checks, Community Relations staff recommends that the agreement be awarded to Astriata, LLC for this service based on the best value to the City meeting all requirements and conditions of the bid specifications; and

**WHEREAS**, the initial contract period will commence upon City Commission approval; and

**WHEREAS**, the City reserves the right to extend the contract; and

**WHEREAS**, the City Commission finds and determines that it is in the best interest of the City to enter into an agreement with Astriata, LLC to provide City website design and implementation services to the City pursuant to IFB No. 05-29-24-11.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the agreement between the City of Coconut Creek and Astriata, LLC, attached hereto and made a part hereof as Attachment “A,” to provide City website design and implementation services pursuant to IFB No. 05-29-24-11.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the agreement between the City of Coconut Creek and Astriata, LLC to provide City website design and implementation services pursuant to IFB No. 05-29-24-11.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
