Annual Report of the City Attorney's Office

This City Attorney's Office report provides a summary of items worked on by me/my office covering the time period from July 1, 2024 through June 30, 2025. Please note that this Memorandum is not all inclusive, but rather it is intended to give you a sampling of the work performed over the last year. Below is a summary that is broken into several categories:

### Cases/Claims:

The City Attorney's Office handled issues involving 1,830 cases/claims during the last year on topics including, but not limited to: personal injury/wrongful death; mortgage foreclosures; bankruptcies; class actions; code enforcement matters; opioid litigation;

PFAS litigation; police liability (police-involved shooting) (wrongful arrest) (false imprisonment); forfeitures; risk protection orders; Marchman Act/Baker Act; worker's compensation; employment matters; whistleblower claims; garnishments; equal employment opportunity claims; land use disputes and appeals (Greystar and Taco Bell); code enforcement appeals (Redstone); and Comprehensive Plan Consistency Challenges (Landfill dispute against Broward County and Waste Management).

The City Attorney's Office reviewed and revised and/or drafted 1,057 agreements/contracts during the last year. In fact, the City Attorney's Office reviewed and responded to over 5,525 general items and held regular Legal Services Meetings with the Departments of Sustainable Development, Utilities and Engineering, Public Works, City Manager's Office, City Clerk's Office, and Finance and Administrative Services regarding pending issues requiring ongoing legal advice.

#### Highlights:

Highlights of the past year include:

1. The Seventeenth Judicial Circuit Court and Fourth District Court of Appeals Dismissed Petitioner's Petition for Writ of Certiorari in the Henri Hage, et. al. v. City of Coconut Creek and Greystar Appellate case.

- 2. Taco Bell of America v. City of Coconut Creek Appellate case was voluntarily dismissed after the City filed its Response to Petitioner's Writ of Certiorari appealing City's decision.
- 3.
