

## **RESOLUTION NO. 2026-010**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO RENEW THE ATTACHED MUTUAL AID AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND THE SEMINOLE TRIBE OF FLORIDA, WHICH PROVIDES FOR MUTUAL AID FOR LAW ENFORCEMENT SERVICES BETWEEN THE PARTIES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Chapter 23, Part I, Florida Mutual Aid Act, Florida Statutes, the Coconut Creek Police Department and other agencies have the authority to enter into a voluntary agreement for cooperation and assistance of a routine law enforcement nature that crosses jurisdictional lines; and

**WHEREAS**, the City of Coconut Creek and the Seminole Tribe of Florida had previously entered into a mutual aid agreement for law enforcement services that expired this year; and

**WHEREAS**, the City of Coconut Creek and the Seminole Tribe of Florida are so close in relation to each other that it is to the advantage of both parties to provide mutual aid to each other in the way of law enforcement and resources in order to adequately respond to multi-jurisdictional criminal and non-criminal activities and emergencies; and

**WHEREAS**, the City of Coconut Creek and the Seminole Tribe of Florida believe that it is in the best interest of the health, safety, and welfare of their residents and visitors to enter into a new mutual aid agreement for law enforcement services effective from August 2, 2025, and expiring on August 1, 2030.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the renewal of the attached mutual aid agreement between the City of Coconut Creek and the Seminole Tribe of Florida for law enforcement services.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the attached mutual aid agreement between the City of Coconut Creek and the Seminole Tribe of Florida for law enforcement services.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
