Section 1: Qualifications and Experience

- a) Clearly describe the ability to perform the scope of services proposed including a work plan with an explanation of the methodology to be followed to perform the services required of this proposal.

EDJ recognizes that the City of Coconut Creek, known as “The Butterfly Capital of the World,” places a high value on environmental stewardship, visual appeal, and public safety. As the City continues to grow and attract residents and businesses, maintaining its green infrastructure in an efficient and sustainable manner is vital. Our objective is to deliver consistent, high-quality lawn and landscape maintenance that enhances the City’s aesthetics, preserves environmental integrity, and reflects the community’s pride and standards of excellence.

EDJ is fully equipped and experienced to perform the comprehensive landscape maintenance services required by the City of Coconut Creek. Our firm’s operational structure, workforce expertise, and established quality control systems ensure the consistent delivery of professional and efficient services across all assigned areas, including medians, right-of-ways, swales, canal banks, and other City-maintained properties.

EDJ operates under a departmental structure designed for maximum efficiency, accountability, and quality control. We employ approximately sixty (60) skilled professionals with specialized experience in turf and landscape maintenance, tree trimming and removal, pest control and fertilization, irrigation repair and installation, and specialty mowing. Our personnel receive ongoing technical and safety training in the latest equipment, environmental standards, and maintenance techniques to ensure compliance with all OSHA and FDOT requirements.

Our organizational approach includes dedicated crews specializing in specific service areas—mowing, bed maintenance, tree care, fertilization and pest control, etc., allowing for expert execution and minimal downtime. Oversight is provided through a clearly defined management chain: each site is supervised by a field supervisor under the direction of the Operations Manager, who personally inspects properties, coordinates schedules, and addresses issues in real time. Frequent inspections, direct communication with City representatives, and a structured reporting process ensure all contractual standards are met or exceeded.

Upon award, EDJ’s main point of contact will be the Operations Manager, Rick Blaha, as well as an Account Manager, Jeanette Wofford. They will meet with City staff to confirm service areas, review expectations, and establish communication and reporting procedures. Dedicated crews, overseen will then be deployed by service type and route, ensuring consistent personnel and site familiarity.

Turf Maintenance and Mowing: Mowing will be performed in accordance with the City's frequency schedule (32 times per year), adjusted seasonally as directed. All equipment will be calibrated to maintain a turf height of three (3) to four (4) inches, ensuring healthy growth without scalping. Litter will be removed before each mowing cycle, and clippings will be cleared from hard surfaces the same day. All mowing operations comply with FDOT safety standards for discharge and traffic control.

Trimming and Edging: Turf edges will be maintained with precision mechanical edging during or immediately following mowing operations. St. Augustine turf areas will be edged and trimmed with every mowing, while Bahia grass areas will be serviced every other mowing cycle. Special care will be taken to protect tree bark, irrigation fixtures, and curbing from equipment damage.

Weed Control: EDJ utilizes an integrated weed management approach that includes manual, mechanical, and selective herbicide applications. Weeds in turf, shrub beds, and along hard surfaces will be removed during every mowing cycle to maintain a clean, manicured appearance.

Fertilization and Pest Control: All fertilization, insect, and disease control will follow the schedule provided in Exhibit "B" using Lesco or equivalent fertilizers. Applications will be performed by licensed and certified personnel. Fire ant and turf insect control will be performed as needed, ensuring a healthy and resilient landscape.

Shrub, Hedge, and Groundcover Maintenance: Shrubs and hedges will be pruned monthly to maintain form, safety clearances, and a uniform appearance. Dead or damaged limbs will be removed promptly. Ornamental grasses will be trimmed annually in late winter or early spring and maintained monthly to remove dead material. All plant beds will be weeded and cultivated prior to each mulching cycle.

Tree Care: All tree services will be performed under the supervision of an ISA Certified Arborist, in compliance with ANSI A300 and Z133.1 standards. Palms will be trimmed annually between May and June; Royals and Bismarcks quarterly. Shade and accent trees will be pruned regularly to maintain clearance and aesthetics. All debris will be removed from the site on the same day in accordance with City standards.

Mulching: Planting beds will be mulched twice annually. A uniform three-inch (3") depth of red mulch will be maintained, and all beds will be weed-free prior to installation.

Litter and Debris Removal: Crews will remove litter and debris before each mowing cycle and dispose of it at an approved facility at EDJ's expense.

EDJ operates under a departmental structure designed for efficiency, accountability, and quality control:

- **Dedicated Crews:** Separate teams specialize in mowing, hedge and bed maintenance, and tree services, ensuring focused expertise in each area.
- **Direct Oversight:** The Operations Manager personally inspects all properties and coordinates with field supervisors to address issues promptly.
- **Quality Assurance:** Frequent field inspections and open communication between supervisors and clients ensure all contractual obligations are met or exceeded.
- **Safety:** All field employees are trained in equipment safety, chemical handling, and traffic control per FDOT standards and each truck and trailer comes equipped with strobes lights, FDOT approved traffic cones and signs.

This structure enables EDJ to maintain consistent service quality, minimize downtime, and ensure that every property reflects the client's standards of excellence.

Richard Blaha, Vice-President/Operations Manager of EDJ Service LLC, will serve as the primary point of contact for this Proposal. Mr. Blaha holds certifications as a Landscape Inspector's Association of Florida (LIAF) Certified Landscape Inspector, Florida Nursery, Growers, and Landscape Association (FNGLA) Certified Horticulture Professional, and ISA Certified Arborist.

Cristian Jimenez-Newbery, Lead Lawn Maintenance Foreman, with over 15 years of experience at EDJ, oversees all lawn maintenance crews, and works directly with the Operations Manager.

Jeanette Wofford, former City Arborist for the City of Cooper City, will be assigned as the Account Manager for the City of Coconut Creek to assist the Operations Manager and supervises all landscape maintenance operations and provides technical oversight to the crews.

Each crew is assigned a dedicated on-site Foreman/Supervisor responsible for:

- Overseeing daily operations and ensuring tasks are performed safely and efficiently.
- Monitoring performance and adherence to specifications.
- Communicating directly with the Operations Manager/Lead Lawn Maintenance Foreman regarding any issues, corrective actions, or client requests.

Lead Lawn Maintenance Foreman, *Cristian Jimenez-Newbery*, coordinates the activities of all crews on-site and conducts random site inspections to verify that all work meets both the City's and EDJ's standards of excellence.

Lawn Maintenance Crews

EDJ typically deploys 4–6 full-time lawn maintenance employees per crew, each assigned to specific routes or properties to ensure familiarity with site conditions and client expectations. These crews perform all routine lawn maintenance services including:

- Mowing
- Edging
- Trimming and weedeating
- Blowing and cleanup

Additionally, EDJ operates one to two dedicated mowing crews consisting of 2–4 employees per team for high-frequency mowing sites or large open areas.

Landscape Maintenance Crews

Dedicated landscape crews perform specialty tasks such as:

- Shrub and hedge trimming
- Bed maintenance and mulching
- Selective pruning

Each crew consists of 4–6 full-time employees who are assigned specific worksites for consistency and efficiency.

 - At least one person should possess a current Tree Trimmer training card.
 - Current training cards reflect that training was completed within the past two (2) years.
 - Picture identification issued by a government entity or agency.
2. At least one trained person must be available at every work site where tree trimming is being carried out.
3. The company's Tree Trimmer license number shall be prominently displayed on both sides of vehicles used in tree trimming.
4. Tree trimmer license number must appear in ads offering tree trimming and/or removal services. Advertisements include business cards, telephone directory advertisements, quotes for tree services, flyers and vehicles advertising tree services.
5. License holders shall ensure that all employees engaged in tree trimming are adequately trained regarding safety procedures in accordance with applicable federal and state law including the federal Occupational Safety and Health Act of 1970 (OSHA).
6. Retraining is required before licenses can be renewed. Tree trimmer licenses are renewable every two years.
7. Each license holder shall notify the County, in writing, if there is a change in any of the standards required for licensure.






