

RESOLUTION NO. 2026-011

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AMENDMENT NO. 2 TO THE AGREEMENT WITH VECTOR FLEET MANAGEMENT, LLC FOR FLEET MANAGEMENT AND MAINTENANCE SERVICES TO PROVIDE FOR THE ADDITION OF TEN (10) FIRE HEAVY VEHICLES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 6, 2018, the City entered into an agreement with Vector Fleet Management, LLC ("Vector") for the purpose of providing maintenance and repair services for the City's fleet of vehicles pursuant to RFP No. 06-27-18-10; and

WHEREAS, on May 13, 2021, the City approved Resolution No. 2021-077, authorizing the City Manager to execute Amendment No. 1 to the agreement, which provided for management and maintenance of seven (7) Fire Administration vehicles to its fleet complement; and

WHEREAS, the parties desire to amend the agreement a second time to add ten (10) Fire Heavy Vehicles to the fleet complement for maintenance and repairs to be conducted by Vector; and

WHEREAS, Vector agrees to maintain and repair the ten (10) new Fire Heavy Vehicles, as detailed in Amendment No. 2, Attachment A - Renewal No. 3 Revised; and

WHEREAS, all service, inspection, and maintenance performed on the Fire Heavy Vehicles under this agreement shall be conducted by a certified Emergency Vehicle Technician (EVT); and

WHEREAS, through Amendment No. 1, the parties superseded and replaced Attachment "A," Schedule of Proposal Prices, to the agreement with a new Attachment "A," Revised Schedule of Proposal Prices, to the agreement; and

WHEREAS, through this Amendment No. 2, the parties will supersede and replace Attachment "A," Revised Schedule of Proposal Prices, to the agreement with Attachment A - Renewal No. 3 Revised, to the agreement; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to amend the agreement a second time with Vector Fleet Management, LLC for fleet Management and maintenance services to add ten (10) Fire Heavy Vehicles.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the Amendment No. 2 to the agreement between the City of Coconut Creek and Vector Fleet Management, LLC, attached hereto and made a part hereof as Exhibit "1," for fleet management and maintenance services pursuant to RFP No. 06-27-18-10.

Section 3: That the City Manager, or designee, is hereby authorized to execute said Amendment No. 2 to the agreement between the City of Coconut Creek and Vector Fleet Management, LLC to provide fleet management and maintenance services for ten (10) additional Fire Heavy Vehicles.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
