

RESOLUTION NO. 2023-063

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A WORK AUTHORIZATION FOR GENERAL PROFESSIONAL ENGINEERING SERVICES WITH CARNAHAN, PROCTOR AND CROSS, INC. TO PERFORM A STRUCTURAL CONDITION SURVEY AND ASSESSMENT FOR FIVE (5) CITY-OWNED BRIDGES IN THE CITY OF COCONUT CREEK IN ACCORDANCE WITH RFQ NO. 03-25-20-02; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek (City) owns and maintains five (5) bridges in South Creek identified by the Florida Department of Transportation (FDOT) as bridge numbers 865005, 865003, 865002, 865001, and 865000; and

WHEREAS, said bridges are over forty (40) years old and are inspected by Florida Department of Transportation (FDOT) every two (2) years, with the last inspection completed in 2021; and

WHEREAS, the City desires to perform a more in depth assessment of said bridges to determine if additional repairs are necessary to ensure the safety of the public; and

WHEREAS, pursuant to Resolution No. 2020-196, the City has an agreement with Carnahan, Proctor and Cross, Inc. to perform general professional engineering services; and

WHEREAS, Carnahan, Proctor and Cross, Inc. provided the City with a proposal to provide a Structural Condition Survey and Assessment for the City's five (5) bridges for a lump sum fee of \$82,555; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to approve the Work Authorization with Carnahan, Proctor and Cross, Inc., to

provide a Structural Condition Surveying and Assessment for the City's five (5) bridges at a cost of \$82,555.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached Work Authorization between the City of Coconut Creek and Carnahan, Proctor and Cross, Inc. for the Structural Condition Survey and Assessment for the five (5) City-owned bridges in South Creek.

Section 3: That the City Manager, or designee, is hereby authorized to execute the attached Work Authorization between the City of Coconut Creek and Carnahan, Proctor and Cross, Inc.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
