A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED CLINICAL AFFILIATION AGREEMENTS WITH THE CITY OF CORAL SPRINGS D/B/A CORAL SPRINGS REGIONAL INSTITUTE OF PUBLIC SAFETY AND THE EMERGENCY EDUCATION INSTITUTE, LLC TO PROVIDE THEIR STUDENTS WITH A COMPREHENSIVE LEARNING EXPERIENCE WITHIN A FIRE RESCUE SETTING DURING EMERGENCY AND NON-EMERGENCY RESPONSES; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Coral Springs D/B/A Coral Springs Regional Institute of Public Safety (CSRIPS) and the Emergency Education Institute, LLC (EEI) provide Emergency Medical Technician (EMT) and Emergency Medical Technician – Paramedic (EMT-P) educational programs; and

WHEREAS, EMT and EMT-P programs require a comprehensive learning experience within a fire-rescue setting during emergency and non-emergency responses, while under the direction of a preceptor; and

WHEREAS, the City desires to enter into the attached Clinical Affiliation Agreements with CSRIPS and EEI to provide the comprehensive learning experience required by the EMT and EMT-P programs while attending emergency and non-emergency responses under the direction of a Coconut Creek Fire Rescue employee preceptor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the Clinical Affiliation Agreements, attached hereto and made a part hereof, between the City of Coral Springs D/B/A Coral Springs Regional Institute of Public Safety and the Emergency Education Institute, LLC and the City of Coconut Creek for the purpose of providing a comprehensive learning experience within a fire-rescue setting.

Section 3: That the City Manager, or designee, is hereby authorized to execute said Clinical Affiliation Agreements.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
