

**RESOLUTION NO. 2023-124**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A WORK AUTHORIZATION WITH R.J. BEHAR & COMPANY, INC. FOR PROFESSIONAL SERVICES TO PROVIDE UPDATED AS-BUILT DRAWINGS FOR THE EXISTING WASTEWATER TRANSMISSION LINE ON COPANS ROAD TO CONDUCT AN INVESTIGATION OF THE LINE PURSUANT TO THE EXISTING CONSULTANT AGREEMENT BETWEEN THE CITY AND R.J. BEHAR & COMPANY, INC. DATED SEPTEMBER 30, 2020; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek (City) owns and maintains approximately 1.12 miles of 20-inch wastewater transmission line (forcemain) along Copans Road from Florida's Turnpike to the Broward County Wastewater Treatment Plant in the City of Pompano Beach; and

**WHEREAS**, the "Copans Road Wastewater Transmission System Improvements" Capital Improvement Program (CIP) was approved in 2014 to provide funding for the construction of a redundant transmission line on Lyons Road and the rehabilitation of the existing Copans Road transmission line that is over 40 years old; and

**WHEREAS**, the construction of the redundancy transmission line on Lyons Road was successfully completed in 2020; and

**WHEREAS**, to evaluate the rehabilitation needs of the existing Copans Road Wastewater Transmission Line, current record drawings (as-built) must be updated due to changes in the Copans Road right-of-way, dating from the original construction of the pipe in the 1970s; and

**WHEREAS**, City staff recommends that the City enter into a work authorization with R.J. Behar & Company, Inc., a consulting company on the City's rotating list selected through the Consultants Competitive Negotiation Act (CCNA) RFQ No. 03-25-20-02 with

an existing agreement with the City dated September 30, 2020, to provide plans and profile drawings of the existing wastewater transmission line on Copans Road, approximately one (1) mile between Florida's Turnpike and the Broward County Wastewater Treatment Plant, in the City of Pompano Beach; and

**WHEREAS**, the City Commission and the City of Coconut Creek finds and determines it to be in the best interest of the City and its residents to approve the work authorization with R.J. Behar & Company, Inc. to prepare updated plans and profiles of the existing Copans Road Wastewater Transmission Line at a cost of \$100,532.86.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and approves the attached work authorization between the City of Coconut Creek and R.J. Behar & Company, Inc., for the preparation of plans and profiles of the existing Copans Road Wastewater Transmission Line between Florida's Turnpike and the Broward County Wastewater Treatment Plant in the City of Pompano Beach.

**Section 3:** That the City Manager, or designee, is authorized to execute said work authorization between the City of Coconut Creek and R.J. Behar & Company, Inc.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
