## **RESOLUTION NO. 2024-092**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENTS BETWEEN THE CITY OF COCONUT CREEK AND INFINITY PLUMBING, INC. (PRIMARY CONTRACTOR) AND R&J PLUMBING AND BACKFLOW SERVICES (SECONDARY CONTRACTOR), ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBITS "1" AND "2" RESPECTIVELY, TO PROVIDE PLUMBING SERVICES ON AN AS-NEEDED BASIS PURSUANT TO RFP NO. 04-24-24-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City's intent of this service contract issued through Request for Proposals (RFP) No. 04-24-24-11 is to establish an agreement with experienced and qualified companies to provide routine and emergency plumbing services on an asneeded basis; and

WHEREAS, the current agreement with Infinity Plumbing, Inc. expires on June 13, 2024; and

**WHEREAS**, on March 10, 2024, the City issued sixty-three (63) electronic invitations through the eBid System and received two (2) responsive submittals; and

WHEREAS, a selection committee comprised of John Tetteris, Public Works Superintendent; John Yancey, Facilities Maintenance Supervisor; and Enrique Castro, Parks and Recreation Superintendent, evaluated the submittals based on the criteria in the RFP; and

WHEREAS, the selection committee ranked Infinity Plumbing, Inc. as number one and R&J Plumbing and Backflow Services as number two based on their qualifications and experience, resources and availability, past performance, and price; and

**WHEREAS**, the selection committee determined that it would be in the best interest of the City to award the contract to a primary and secondary contractor; and

WHEREAS, based upon the schedule of proposal prices outlined in Exhibit "A" of the agreements as well as the information in their proposal, and the results of the background and reference checks, the selection committee is recommending that Infinity Plumbing, Inc. be awarded the primary contract and R&J Plumbing and Backflow Services be awarded the secondary contract for this service; and

WHEREAS, the initial contract period shall be for three (3) years with the option to renew for two (2) additional one (1) year periods; and

WHEREAS, the City Commission deems it to be in the best interest of the residents of the City of Coconut Creek to contract with Infinity Plumbing, Inc. and R&J Plumbing and Backflow Services to provide plumbing services to the City on an asneeded basis.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the agreements, attached hereto and made a part hereof as "Exhibit 1" and "Exhibit 2" respectively, between the City of Coconut Creek and Infinity Plumbing, Inc. (primary contractor) and R&J Plumbing and Backflow Services (secondary contractor) to provide plumbing services on an as-needed basis.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the aforementioned agreements between the City of Coconut Creek and Infinity Plumbing, Inc. (primary contractor) and R&J Plumbing and Backflow Services (secondary contractor) to provide plumbing services on an as-needed basis.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
