

**RESOLUTION NO. 2021-077**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND VECTOR FLEET MANAGEMENT, LLC FOR FLEET MANAGEMENT AND MAINTENANCE SERVICES TO PROVIDE FOR THE ADDITION OF SEVEN (7) NEW FIRE ADMINISTRATION VEHICLES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City contracts with Vector Fleet Management, LLC for the purpose of providing maintenance and repair services for the City's fleet of vehicles; and

**WHEREAS**, the City will be providing for its own fire services beginning in Fiscal Year 2022 and as such will be adding seven (7) vehicles to its fleet complement; and

**WHEREAS**, the parties desire to amend the agreement between the City of Coconut Creek and Vector Fleet Management, LLC to provide for the maintenance and repair of the aforementioned vehicles; and

**WHEREAS**, staff recommends approval of Amendment No. 1 to the agreement between the City of Coconut Creek and Vector Fleet Management, LLC for the purpose of providing maintenance and repair services for the addition of seven (7) Fire Administration vehicles; and

**WHEREAS**, the City Commission of the City of Coconut Creek believes it is in the best interests of the City to amend the agreement between the City of Coconut Creek and Vector Fleet Management, LLC for the purpose of providing maintenance and repair services for the addition of seven (7) Fire Administration vehicles.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached Amendment No. 1 to the agreement between the City of Coconut Creek and Vector Fleet Management, LLC to provide for the maintenance and repair of seven (7) additional Fire Administration vehicles.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute Amendment No. 1 to the agreement between the City of Coconut Creek and Vector Fleet Management, LLC to provide for the maintenance and repair of seven (7) additional Fire Administration vehicles.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.

This Amendment No. 1 to the Agreement between the City of Coconut Creek and Vector Fleet Management, LLC for Fleet Management and Maintenance Services dated October 6, 2018 is made this 6<sup>th</sup> day of OCTOBER, 2021 by and between the City of Coconut Creek, Florida, (the "City"), and Vector Fleet Management, LLC (the "Contractor") both of whom agree as follows:

**WITNESSETH:**

**WHEREAS**, the parties desire to amend the Agreement between the City of Coconut Creek and Vector Fleet Management, LLC for Fleet Management and Maintenance Services dated October 6, 2018 ("Agreement") to add seven (7) Fire Administrative Vehicles to the fleet for maintenance and repairs to be conducted by Vector; and

**WHEREAS**, Contractor agrees to maintain and repair the seven (7) new Fire Administrative Vehicles.

**NOW, THEREFORE**, based on the promises and covenants herein contained, the parties agree as follows:

1. The recitations referred to above are hereby incorporated herein.
2. The parties desire to amend the Agreement by amending Attachment "A" "Schedule of Proposal Prices" of the Agreement to add the seven (7) new Fire Administrative Vehicles to the Targeted Operating Budget Services for year Four (4) and year Five (5) as provided in the Amended Attachment "A" Revised, attached hereto and incorporated herein.


3. All other terms and conditions of the Agreement not in conflict with this Amendment No. 1 shall remain in full force and effect and are incorporated herein.



Comments: Amendment No. 1 is post-dated October 6, 2021 because it will not take effect until then. We wanted to have it in place for the Fire Department vehicles, which will be put into use at different times during the summer of 2021 as administrative personnel are hired and begin work.

For the remainder of this contract year (up through October 5, 2021) there will not be any cost added, as any expense would just be handled through the shared savings cost/expense.

Amendment No. 1 pricing is for contract years 2021-2022 (year four) and 2022-2023 (year five), which finish out the fixed 5 year pricing of the original term of the agreement.
