

**RESOLUTION NO. 2024-128**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AMENDMENT NO. 1 TO THE AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND CRAIG B. KUSHNIR D.O., LLC TO CONTINUE TO PROVIDE MEDICAL DIRECTOR SERVICES FOR COCONUT CREEK FIRE RESCUE AND THE CITY OF COCONUT CREEK; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Chapter 401, Florida Statutes, and Chapter 64J, Florida Administrative Code, provide the requirements for an agency providing an Emergency Medical Services System, which employs or utilizes Emergency Medical Technician (EMT) and/or Paramedics to perform basic and/or advanced life support procedures. The City of Coconut Creek must hire a Medical Director, who is a Board Certified Physician pursuant to Chapter 458, Florida Statutes; and

**WHEREAS**, the City of Coconut Creek previously entered into an agreement with Dr. Craig B. Kushnir as the City's Medical Director; and

**WHEREAS**, the parties desire to amend certain terms and conditions of the agreement in accordance with this Amendment No. 1 and agree to the new terms and conditions, as set forth therein; and

**WHEREAS**, the City of Coconut Creek agrees to extend the agreement for three (3) years as contemplated in the agreement and further agrees to provide Craig B. Kushnir, D.O., LLC, a \$400 increase in the monthly amount paid to the Medical Director from \$3,250 to \$3,650 per month, following the City's implementation of its community-based paramedic service, which would increase the scope of Dr. Kushnir's services and responsibilities.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves Amendment No. 1 to the agreement, attached hereto and made a part hereof, between the City of Coconut Creek and Craig B. Kushnir D.O., LLC for Medical Director Services for Coconut Creek Fire Rescue and the City of Coconut Creek.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute Amendment No.1 to the agreement with Craig B. Kushnir D.O., LLC to provide Medical Director Services for Coconut Creek Fire Rescue and the City of Coconut Creek.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
