

RESOLUTION NO. 2024-044

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN HOMELAND SECURITY INVESTIGATIONS AND THE CITY OF COCONUT CREEK TO PROVIDE THE CITY WITH REIMBURSEMENT OF COSTS INCURRED IN PROVIDING RESOURCES TO THE JOINT OPERATIONS/TASK FORCES SYSTEM; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Treasury Forfeiture Fund Act of 1992 provides for the reimbursement of certain expenses incurred by local, county, and state law enforcement agencies as participants of joint operations/task forces with a federal agency participating in the Treasury Forfeiture Fund; and

WHEREAS, the City is desirous of entering into this MOU with Homeland Security Investigations to be eligible for reimbursement of costs incurred by the City when providing resources to joint operations/task forces with the agency; and

WHEREAS, the MOU establishes the responsibilities of each party and provides the guidelines the City must follow when requesting reimbursement; and

WHEREAS, the City Commission finds and determines that is in the best interest of the City to enter into the MOU with Homeland Security Investigations necessary to receive reimbursement of costs incurred by the City when providing resources to joint operations/task forces.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the MOU between Homeland Security Investigations and the City of Coconut Creek for the purpose of the reimbursement of costs incurred by the City in providing resources to joint operations/task forces.

Section 3: That the City Manager, or designee, is hereby authorized to execute said MOU between Homeland Security Investigations and the City of Coconut Creek, attached hereto and made a part hereof.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
