A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AMENDMENT NO. 2 TO THE PARTNERSHIP AGREEMENT WITH JUNIOR ACHIEVEMENT OF SOUTH FLORIDA, INC. FOR SPONSORSHIP OF TWO (2) COCONUT CREEK GOVERNMENT **BIZTOWN** STOREFRONTS TO PROVIDE FOR THE EXTENSION OF THE AGREEMENT FOR AN ADDITIONAL THREE (3) YEAR TERM; **PROVIDING FOR SEVERABILITY:** PROVIDING AN EFFECTIVE DATE.

WHEREAS, Junior Achievement of South Florida (JASF) JA World is located in the City of Coconut Creek; and

WHEREAS, the City entered into an agreement with JASF on August 11, 2016, to sponsor two (2) Coconut Creek Government storefronts, which enhance educational opportunities for the 20,000+ fifth grade students that participate in JA World's BizTown each year; and

WHEREAS, the City entered into a new agreement on July 1, 2019 ("Agreement") to continue sponsoring two (2) Coconut Creek Government storefronts in JA World's BizTown, and the City extended the Agreement on August 25, 2022, for an additional three (3)-year term by executing Amendment No. 1 to the Agreement; and

WHEREAS, partnering with JASF allows for additional economic development, networking, and branding opportunities for the City; and

WHEREAS, the City desires to extend the Agreement in order to continue this partnership with JASF for an additional three (3) year term; and

WHEREAS, the annual payment shall not exceed \$50,000 without written authorization.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached Amendment No. 2 to the Agreement with Junior Achievement of South Florida, Inc. as a storefront sponsor in JA World.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the attached Amendment No. 2 to the Agreement with Junior Achievement of South Florida, Inc.

Section 4: That the annual payment shall not exceed \$50,000 without written authorization.

<u>Section 5:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 6: That this resolution shall be in full force and effect immediately upon its adoption.
