

RESOLUTION NO. 2026-069

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A WORK AUTHORIZATION WITH WGI, INC. IN AN AMOUNT NOT TO EXCEED \$70,000 TO CONTINUE REVIEW AND INSPECTION SERVICES FOR THE LANDSCAPE DIVISION OF THE RESILIENT DESIGN AND DEVELOPMENT DEPARTMENT PURSUANT TO RFQ NO. 10-06-21-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on January 18, 2022, the City entered into a master agreement with WGI, Inc. to provide professional services pursuant to RFQ No. 10-06-21-11; and

WHEREAS, under this master agreement, WGI, Inc. was retained to provide landscape review and inspection services to support the Landscape Division of the Resilient Design and Development Department in an initial amount of \$25,000; and

WHEREAS, this initial award did not anticipate staff loss due to retirement and additional workload demands; and

WHEREAS, the City desires to continue utilizing WGI, Inc. for landscape review and inspection services, which include all of MainStreet, as well as other projects as needed; and

WHEREAS, staff recommends approval of this Work Authorization with WGI, Inc. to continue providing landscape review and inspection services for the Landscape Division of the Resilient Design and Development Department in an amount not to exceed \$70,000; and

WHEREAS, the City Commission of the City of Coconut Creek finds and determines it to be in the best interest of the City to approve the Work Authorization with WGI, Inc. to continue providing landscape review and inspection services for the Landscape Division of the Resilient Design and Development Department in an amount not to exceed \$70,000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached Work Authorization between the City of Coconut Creek and WGI, Inc. to continue providing landscape review and inspection services for the Landscape Division of the Resilient Design and Development Department in an amount not to exceed \$70,000 pursuant to RFQ No. 10-06-21-11.

Section 3: That the City Manager, or designee, is hereby authorized to execute the attached Work Authorization between the City of Coconut Creek and WGI, Inc. to continue providing landscape review and inspection services for the Landscape Division of the Resilient Design and Development Department in an amount not to exceed \$70,000 pursuant to RFQ No. 10-06-21-11.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
